The Kemah Community Development Cooperation (KCDC) hereby gives notice, pursuant to Texas Local Government Code, Sec. 505.158, that it will conduct a sixty (60) day comment period that will open on June 10, 2024, and will close on August 12, 2024 for the consideration to use Type B sales tax funds for the Lighthouse District Streetscape Project and 6th Street Pavilion.
