Paul Williams 121 Votes


Lee Wallace 135 Votes



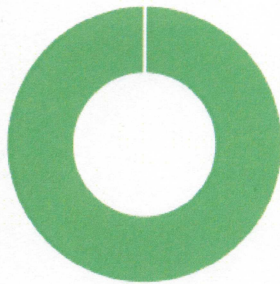
